Institution Feedback Mechanism-

Feedback is an important part of academic activity, which helps us to enhance the quality of teaching. The institute has a multidimensional, well defined process of assessment including reviews by students and teaching faculties, employers and alumni. Feedback is conducted for all academic programs in every semester.

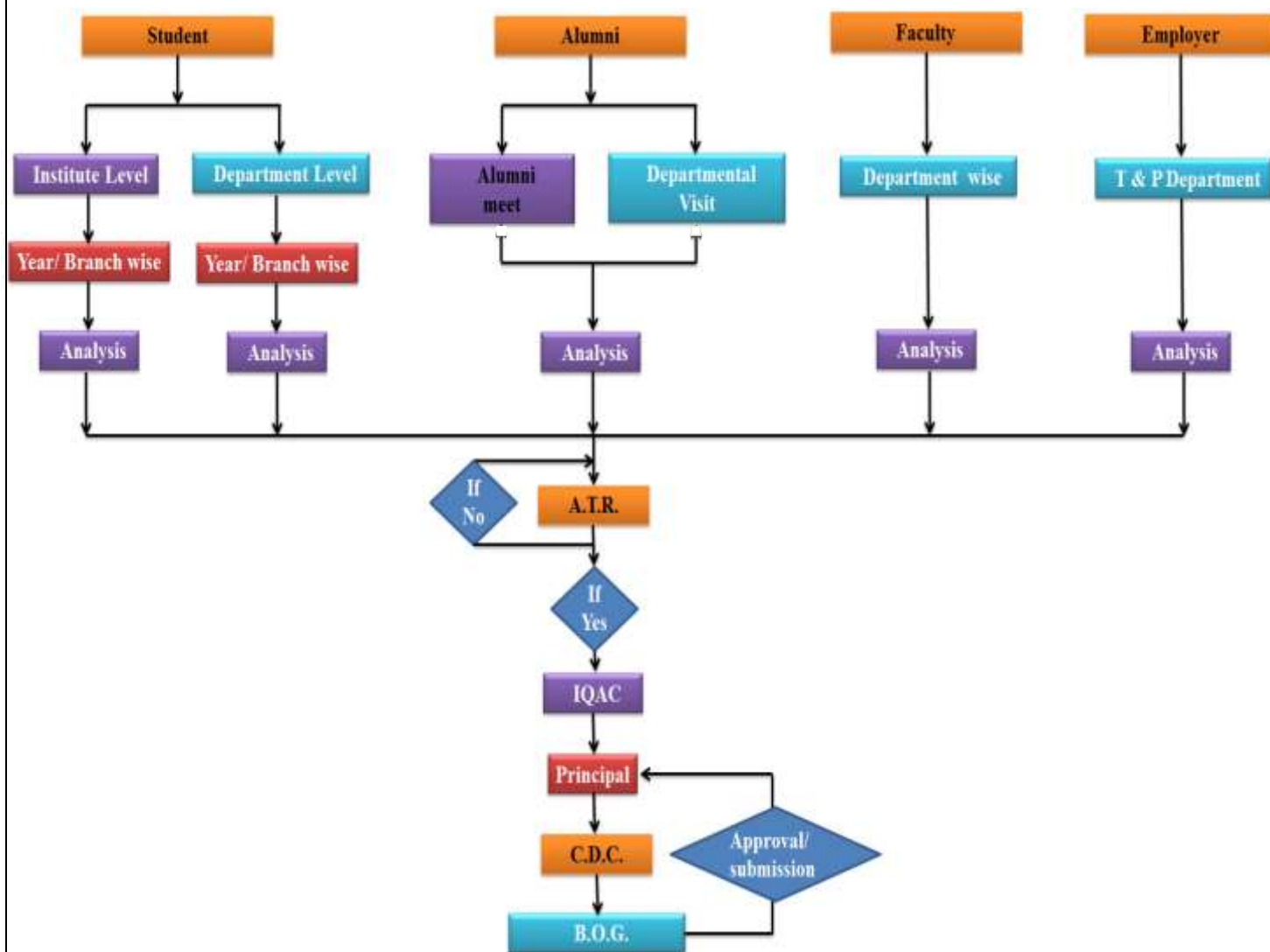

The students' Academic feedback includes the following:



This assessment is conducted to review, how a teacher's teaching for a particular subject is perceived by students. With respect to a subject-teacher's teaching, following questions are asked and teacher's feedback is assessed on the scale of 1 to 4 in online mode. Apart from the above questions, comments section is offered where students can raise concerns which are not addressed through the questions in feedback form or give suggestions to the teacher. Format for the feedback containing, questionnaire to assess the course curriculum, teaching learning experience, knowledge and skill development of the student, participation and conduction of co-curricular activities, extra-curricular and extension activities organized at departmental and institute level and about facilities available in the institute, is prepared by heads of department in consultation with the Principal and Vice Principal and approved in IQAC meeting. Online feedbacks are undertaken in each semester for each course/subject from students. Feedback about Institute infrastructure and facilities is taken at the end of each session. The overall aim is to ensure quality in the teaching-learning process. Teaching-Learning assessment is conducted with respect to the individual department in the context. Feedback committee is constituted at institute level with coordinators from each department.

Process followed for each cycle is as below:

1. Configure Feedback schedule for the institute
2. Ensure subject teacher allocations are properly done.
3. Ensure all the courses/ subjects everything configured for the review process
4. On successful review and verification, the feedback links are circulated / published for students to submit feedback.
5. Link is available for a specific duration. If needed, reminders in the form of messages are sent again. Also at times, dates for accepting the responses can be extended.
6. Once the responses are collected, departmental coordinators reviews each comment and prepares department specific reports.
